3.	Passport/travel document must: a) have a validity of at least 3 months after the intended stay b) be issued within the previous 10 years c) have 2 blank pages (It is recommended to attach old passports as well.)		
4.	Reservation of return ticket and transportation in Schengen area (if applicable)		
5.	Confirmed accommodation reservation for the entire journey		
6.	Travel medical insurance valid for all Schengen countries with 30 000 Euros daily coverage and valid for all risks. (Correct spelling of the name and passport number is essential)		
7.	Employees: certificate of employment + payslips for the last three months, certificate of affiliation to Tamin-e Ejtemaei (Social Security Organization)/Khadamat-e Darmani (Health Services Organization) or equivalent, or letter of the employer explaining who this certificate is issued to Traders: proof of entry in the trade register + proof of membership of Tamin-e Ejtemaei (Social Security Organization)/ Khadamat-e Darmani (Health Services Organization) or equivalent if applicable Directors or shareholders of Iranian companies: introduction letter signed by a legal representative of the company confirming the office or status of the applicant; proof of existence of the company in Iran (Official Journal); proof of appointment if not mentioned on the Official Journal		
8.	For minors (less than 18 years old) a declaration by the legal representative about the coverage of the costs, certified by notary public. If travelling alone or with one parent (legal representative), minors are requested to present a declaration from the other parent that he/she can travel abroad		
9.	Bank account statement and circulation of the same account for the last 3 months		
10.	Proof of ownership of property in Iran is recommended		
11.	Official translation of birth certificate (Shenasnameh)		
12.	Copy of the passport and previous visas

- Original documents must be presented during the personal interview with the visa officer and a copy must be submitted.
