1	<p><b>Visa application form, original:</b></p> <p>Duly filled out, dated and signed by the applicant. <b>The visa application form must be signed by both parents in case of minor child.</b></p> <p><a href="#">Click here to download the Schengen visa application form.</a></p> <p><b>It is mandatory that the mentioned data information on the Schengen visa application form such as addresses, phone numbers etc. has to be identical with the personal data of the applicant. If this requirement is not fulfilled the visa application will be refused.</b></p>			
2	<p><b>Two passport-sized pictures 3.5 cm x 4 cm:</b></p> <ul style="list-style-type: none"> <li>- Color photo on a white background</li> <li>- Format 3.5 cm x 4 cm</li> <li>- Taken from the front; without obstruction</li> <li>- Recent (less than 6 months old)</li> <li>- Ears and eyebrows must appear on the picture</li> </ul> <p><b>The photo must be a close-up of your head and the top of your shoulders so that your face takes up 70-80% of the photograph.</b></p>			
3	<p><b>Passport, original:</b></p> <p>Valid for at least three months after the end of the planned stay in Switzerland or another Schengen Member State, <b>at least two blank pages. Please present previous passports if available</b></p>			
4	<p><b>Passport, copies:</b></p> <p>Two photocopies of the passport (personal data page)</p>			
5	<p><b>Change name and/or surname certificate, if applicable:</b></p> <p>Show original and submit photocopy</p>			
6	<p><b>Passport of the EU/EEA citizen:</b></p> <p>One photocopy of the passport (personal data page).</p>			
7	<p><b>Copy of valid Swiss residence permit of the EU/EEA citizen:</b></p> <p>Not required if EU/EEA citizen is not living in Switzerland.</p>			
8	<p><b>Copy of marriage registration from the EU/EEA citizen's home country:</b></p> <p>Not older than six months.</p>			

The visa application procedure is facilitated for spouses and registered partners of EU/EEA citizens. Spouses and registered partners of EU/EEA citizens can submit their application for a Schengen visa during the opening hours at the Regional Consular Center Bangkok without prior appointment. The appearance in person is required. The visa application cannot be submitted by courier.

**Fees:** The visa application is free of charge.

**Further information:** The submission of a travel and health insurance and of a flight reservation is not required. The passport can be picked up the next working day during the opening hours without prior appointment. The passport can also be returned to an address in Thailand by EMS if a self-addressed prepaid envelope (post stamp THB 50.00) is submitted. The Regional Consular Center Bangkok does not issue a visa to a citizen of a Schengen Member State who additionally holds the nationality of a third state.

Documents in Thai language must be translated into English or into one of the Swiss national languages (G, F, I) by a translation office.

If submitting documents to prove family relationships from countries other than Thailand, legalization from competent Embassy or Consulate is required.
